

Pet Addendum To Lease Agreement

This ADDENDUM is made on _____ between Landlord and Tenant or Tenants and understood to be included and recognized as Attachment A to modify the Lease (the "Lease") between Landlord and Tenant(s) dated _____ as follows:

I. Authorization of Pet(s) at Property Location:

Landlord grants permission to Tenant to keep the pet(s) described herein on the Premises (also referred to as "Property") subject to the terms and conditions of the Lease and this Addendum. Landlord may revoke permission at any time if Tenant fails to comply with any of the terms of the Lease and this Addendum or if the pet(s) provides a problem or nuisance to roommates or surrounding tenants and no refund will be granted for monies paid.

II. Service, Guide, Signal, or Support Animal:

Under the Americans with Disabilities Act (ADA), the term "pet" excludes a service, guide, signal, or support animal used by Tenant because of blindness, or deafness, or because of a physical handicap, or because the Tenant is a handler or trainer of support or guide animals. The ADA defines "service animal" as a dog that has been individually trained to do work or perform tasks for the benefit of an individual with a disability.

The laws of the State of Georgia make it illegal for a Landlord to refuse to rent property or to otherwise discriminate against any person on the basis of a service animal. Service animals and lease agreements are also guided by federal law under the ADA as well as under the Fair Housing Act.

Tenant is responsible for covering any cost associated with replacement of carpets, repairs or damage for any pet in the leased apartment.

V. Animal Registration

I understand that all monies paid and to be paid that are associated with this agreement, only cover the pet listed on this addendum. I will not allow any other pets on the Leased Property. I Consent for Hendley Properties to Withdraw the additional \$25 out of my account if I am on a card or check draft.
